The Town of Seven Devils is Updating the Comprehensive Land Use Plan

The Comprehensive Land Use Plan (CLUP) was first approved in 2001 and last updated in 2018.

What the CLUP is:

A comprehensive document that incorporates a Vision Statement, History and Demographic Data to help guide staff, officials, residents and visitors on the towns desired trajectory for future development in relation to the character of the town.

What the CLUP is Not:

The plan is not an enforceable document to regulate zoning, short-term rentals or commercial or residential development, this is done through the unified development ordinance or other land use ordinances.

Is the CLUP Important:

Yes, the State of NC requires all municipalities with zoning regulations to adopt and refer to a land use plan when making zoning decisions.

Can I speak into the changes being made to the CLUP?

Yes, the plan will be reviewed by the Planning Board in the next few months and the Town Council will hold a public hearing to discuss the plan. Citizens may comment prior to these meetings on the town's public comments section of the town website, email <u>publiccomments@sevendevilsnc.gov</u> with "CLUP Review 2024" in the subject line or in person at one or both of the board meetings.
