# TOWN OF SEVEN DEVILS PUBLIC HEARING & TOWN COUNCIL REGULAR MEETING

## March 16, 2017

The Seven Devils Town Council met for a Public Hearing for the Recreational Trails Program Grant on Thursday, March 16, 2017, at 5:00PM and in a Regular Meeting at 5:30PM at Town Hall. Present at the Public Hearing were Mayor Larry Fontaine, Mayor Pro Tem Brad Lambert, Council Members Kay Ehlinger, David Ehmig, David Hooper, and Manager Debbie Powers; Town Attorney Rob Angle joined at the Regular Meeting; the minutes were recorded by Town Clerk Hillary Gropp.

#### PLEDGE OF ALLEGIANCE

Council members and citizens recited the Pledge of Allegiance.

#### CALL TO ORDER

Mayor Fontaine explained the rules of a Public Hearing and then asked for a motion to open the Public Hearing.

Member Hooper called to open the Public Hearing at 5:00PM. Member Ehlinger seconded the motion. The members agreed unanimously.

# **PUBLIC HEARING PRESENTATION**

Manager Powers gave a brief explanation the purpose of this Public Hearing was to discuss the Recreational Trails Grant opportunity.

Manager Powers introduced the speakers, Eric Hiegl and Ben Lucas with the Blue Ridge Conservancy and Kelly Coffey with High Country Council of Governments. Ben Lucas gave a history of the Blue Ridge Conservancy. The recently acquired grants allowed for the purchases of the 245-acre Peak Mountain tract and the 20 acre Penland tract. This is a prime opportunity to protect a significant ridgeline and expand public access which is a main mission of the BR Conservancy. The BR Conservancy is completely supportive of all measures necessary, including annexation in to complete future trails.

Member Ehlinger initiated discussion about possible camping in the future, however it is too preliminary to be determined yet. Member Hooper is extremely pleased with land acquisition to date.

Kelly Coffey reports these are federal funds being filtered through the state trails program and priority is given to hiking trails and trail extensions. This grant application should be favorable because of matching funds and the project is construction ready. The grant is a 25-75% split with the Town of Seven Devils contributing \$20,000, the grant amount is \$60,000 for a total project of \$80,000. Mr. Coffey will follow up if resident letters of support are needed to help persuade to acquire grant.

Eric Hiegl offered positive remarks for the cooperative relationship with Seven Devils in realizing the goal of the Recreational Trails Program and provided additional details about the Penland tract and removal of existing structures, as well as property division for best use.

Sales tax distribution from Watauga County will potentially change from a payback of 60% to 70% causing a \$21,000 revenue loss. To date, a final meeting has **not been** scheduled to resolve this issue with the County, Blowing Rock and Beech Mountain.

A RESOLUTION BY THE TOWN COUNCIL OF THE TOWN OF SEVEN DEVILS, NORTH CAROLINA, URGING THE WATAUGA COUNTY COMMISSIONERS TO MAINTAIN THE AD VALOREM METHOD OF DISTRIBUTION OF SALES TAX IN WATAUGA COUNTY

WHEREAS, N.C.G.S. \$105-472 provides for the ellocation of sales tas between cities and countles within North Carolina; and WHEREAS, N.C.G.S. \$105-472(b) allows a Board of County Commissioners to determine on a yearly basis, whether such allocation is made on a per capita distribution or an ad valorem distribution, and

WHEREAS, the 3d valoram method of sales tax distribution recognizes the value of property is distributed equitably throughout Watauga County; and

WMEREAS, the Town of Seven Devik apprepares and values its good working relationship with Walauga County, and the ability to mutually benefit the critises of both the Town of Seven Devik and Walauga County, and

WHEREAS, the Town of Seven Davib looks forward to continuing to assist Watsuga County in addressing financial needs with Sales Tax revenues should the ad valoram method be used in determining Sales Tax distribution for fiscal year 2017-2018; and

WHEREAS, a mutually financisty beneficial relationship was established provides by between the Town of Seven Devils and Watauga County; and

WHEREAS, the Town of Seven Devils would him to continue this she ad fine nds ty beneficial relationship for the flacal year 2017-2018, through the budgetary pruness, an amount equal to seventy per gent (70%) of the Increase in gross revenues scrunge to the Town over and above the amount which would otherwise been realized under the per capito method, to costs and espenditures as requested by Watsuga County.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Sevan Devils, North Carolina, hereby strongly urges the Walauge County Commissioners to exercise their authority thiring the month of April 2017, to maintain the ad valorem method of Sales Tan distribution in Walauge County.
