TOWN OF SEVEN DEVILS TOWN COUNCIL MINUTES – REGULAR MEETING

July 8, 2014

The Seven Devils Town Council met in regular session on Tuesday, July 8, 2014, at Town Hall. Present were Mayor Larry Fontaine, Mayor Pro Tem Brad Lambert, Council Members Kay Ehlinger, David Hooper, and David Ehmig. Also present were Town Attorney Rob Angle and Town Manager Ed Evans. The minutes were recorded by Sara Miller, Town Clerk.

CALL TO ORDER

Mayor Fontaine called the meeting to order at 5:30 PM.

PLEDGE OF ALLEGIANCE

Council members and citizens recited the Pledge of Allegiance

ADOPT AGENDA

Mayor Fontaine stated that Agenda Item VI Presentation—Resolution of Appreciation for Lois Dodson, would need to be moved to the August Town Council meeting. Member Ehmig made a motion to adopt the amended Agenda. Member Hooper seconded the motion. The members agreed unanimously.

Member Ehlinger made a motion to adopt the Consent Agenda. Member Ehmig seconded the motion. The members agreed unanimously.

CITIZEN COMMENTS

Kay Lambert, 430 Wildcat Rocks, stated that SafetyFest was a great success the previous Saturday. She also wanted to thank all volunteers and employees for the hard work they put into making it a special day.

ADMINISTRATIVE UPDATE & CALENDAR—Town Manager Evans stated that the ABC Board would meet on July 10, at 4:00PM. Mayor Fontaine asked Manager Evans for an electronic sign update regarding the complaints that have been voiced. Manager Evans told the Council that the solution to turn the sign off during the night seemed to have satisfied the residents that complained, and the residents have already thanked the Town for finding this solution.

Manager Evans gave special thanks to all of the Seven Devils Volunteer Fireman, as a special thankyou note had been given to the Town for the great work by several of the volunteers. He stated that the note and a list of all the Volunteer Fireman could be found in the Summer Echo, available at Town Hall.

Member Ehmig wished to mention that Volunteer Fireman Tom Bookstaver did an outstanding job at SafetyFest talking to and working with children and their families, explaining how the fire equipment worked. Manager Evans expressed his appreciation to Volunteer Fireman Bookstaver for working with the families and explaining how the fire trucks and equipment operated.

OLD BUSINESS

APPROVE UDO CHANGES TO BUILDING SETBACK REQUIREMENTS AND


BUILDING HEIGHT—After brief discussion, Member Hooper made a motion to approve the UDO changes to building setback requirements and building height. Member Ehmig seconded the motion. The members agreed unanimously. **~CLOSED~**

PUBLIC WORKS RECOMMENDATION—ROAD ANALYSIS—Mayor Fontaine stated that this issue was to be tabled until the August Town Council meeting. Mayor Pro Tem Lambert stated that the Public Works committee would be meeting this month to discuss this issue. No action was taken. **~OPEN~**

NEW BUSINESS

REQUEST FOR RELIEF—WATER BILL—BOB GROSBY—Larry Fontaine stated that Mr. Bob Grosby was present at the meeting to approach the Council about relief on his previous high water bill. Mr. Grosby proceeded to request relief on his water account, for a bill that was for approximately \$1,179.00, due to high water usage. He asked that the Council remember his part in obtaining the Town tennis courts, and that he understood there was no verified leak, but a mistake made. After discussion, Mayor Fontaine called for a vote by the Council, on whether or not to reduce Mr. Grosby's bill according to the verified leak requirements in the Water Use Ordinance. There were 2 Ayes (Mayor Fontaine and Member Ehlinger) and 3 Nays (Mayor Pro Tem Lambert, Member Hooper, and Member Ehmig). Relief was not granted to Mr. Grosby. No action was taken. ~CLOSED~

APPROVE RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION FOR APPROVAL OF A FINANCING AGREEMENT—STATE OF NORTH CAROLINA, DEPARTMENT OF STATE TREASURER, STATE AND LOCAL GOVERNMENT FINANCE DIVISION AND THE LOCAL GOVERNMENT COMMISSION—Mayor Pro Tem Lambert made a motion to approve the Resolution authorizing the filing of an application for approval of a financing agreement with the State of North Carolina Department of State Treasurer State and Local Government Finance Division and the Local Government Commission. Member Ehlinger seconded the motion. The members agreed unanimously. ~CLOSED~
