

**Town of Seven Devils**  
Planning Board Minutes  
Regularly Scheduled Meeting  
September 17, 2013

The Seven Devils Planning Board met on Tuesday, September 17, 2013, at Town Hall. Chair Butch McLean called the meeting to order at 5:30 p.m. Members present were Bob Haugh, George Ehlinger, Barry Isquith, and Brady Sasse. Members Barbara Williams and Frank Sell were absent. Town Manager/Zoning Administrator Ed Evans was also present. The minutes were recorded by Sara Miller, Town Clerk.

**Adopt Agenda**

Member Isquith made a motion to adopt the agenda. Member Sasse seconded the motion. The members agreed unanimously.

**Approve Old Minutes – August 20, 2013**

Member Isquith made a motion to approve the August 20, 2013 minutes. Member Haugh seconded the motion. The members agreed unanimously.

**Administrative Comments**

Manager Evans gave the board a Town construction update, stating that there was nothing new to report, as no new permits or projects had been presented to him. Manager Evans stated that Jeff Kattner, 120 Buckeye Lane, has decided to rebuild his house and turned in a set of plans to him the previous week, stating that a contractor would be finalized that week.

**Alternative Energy Resources—UDO**—Manager Evans stated that the draft Ordinance presented in the packet was taken from several different examples after extensive research, and molded to be pertinent to Seven Devils. He also stated that the alternative energy topic was not a big issue in Seven Devils, because to date there had been no inquiries or requests to utilize those energy resources. After some discussion, Chair McLean stated that the Planning Board should recommend the draft Ordinance to the Town Council for consideration and approval.
