MINUTES

The meeting was called to order at 5:30pm by George Ehlinger, Chairman.

Dick Nelson moved to approve the September 3, 2013 Minutes. Leigh Sasse seconded. All members agreed.

Leigh Sasse moved to adopt the Agenda. David Hooper seconded. All agreed.

B. 2013 Wish Lists - Mike Tarlton reported that Fire, Police and Public Works applied their allocated funds to purchase:

Fire: Responder Parkas - \$3,000 used to match the State Fire Grant (a 50/50 grant)

Police : combined with money from previous years for video cameras in vehicles.

Public Works: Boots, gloves, etc. per person @\$300. Remainder set aside for future purchases.

- \* Grills - Earl Pariseau will check with Ian (SD resident and co-owner of Sunrise Grill) about borrowing or perhaps purchasing theirs. Ed will check with his sources.
- \* Sponsors packets are complete and will be mailed this week. Placemat Ad participants will also be contacted.
- \* Banners, Signs, Sponsor Board - Kay Ehlinger and Kay Lambert will check with a number of businesses about updating costs.

- \* TDA voted to donate \$5000 as a Platinum and Placemat Ad Sponsor.
  - \* Hawks Peak Condo Association has approved the use of the upper lot for SafetyFest
  - \* Pepsi Bottling Ventures will be contacted concerning the use of the Pepsi Wagon (Kay Lambert)
  - \* Freeman Gas will be contacted about propane grill tanks being filled (Kay L.)
  - \* Craft Booths - Kay Lambert will contact previous participants. A notice will be put in the Echo and on some area bulletin boards about availability of spaces. Mike Tarlton and Brady Sasse will see if the Resort Club has an interest in doing a "Country Store" (gently used items donated and sold with proceeds split with Public Safety.)
  - \* Bobby Powell will check about the ladder truck and the smoke house. The Fire Department already has the squirt house.
  - \* Recreation Commission will be asked if it plans to have the "Kids' Carnival" and sell duplicate books.
  - \* David Hooper requested that an inventory be made of safety items and Town memorabilia to be sold at the Public Safety Committee Booth. Kay Lambert agreed to do so.
  - \* The Committee voted unanimously to allot up to \$1,000 for the purchase of five major raffle prizes.
  - \* Leigh Sasse - BLESS HER - agreed to be incharge of raffle and silent auction collections. THANK YOU LEIGH!!!
- B. Safety Concerns - Earl Pariseau and Dick Nelson addressed their concerns about safety on foggy nights on the roadways. Painting sidelines and center lines is not financially feasible. The lines and embedded reflectors come up and fade with repeated plowing. Plastic reflectors would not last long with plowing and grass cutting.
