

Town of Seven Devils  
Recreation Commission  
Minutes –Regular Session  
September 10, 2013

The Town of Seven Devils Recreation Commission met at 4:00 in Town Hall on September 10, 2013. Members present were Anne Fontaine, Kay Lambert and Leigh Sasse. Tom Bookstaver, Martha Stearns and Mike Potter were absent.

Ed Evans was also present.

Chair Anne Fontaine called the meeting to order and distributed copies of the agenda.

Under **Old Business** in the August 13, 2013 minutes it was noted that Kay Lambert's name was misspelled. We need to change spelling from Key to Kay. Kay Lambert moved to accept the minutes of August 13, 2013 with this change. Anne Fontaine seconded the motion, and it passed.

**New Business**

Anne Fontaine reported that we have \$360.68 in PBSB and \$250.00 that we received in donations at SafetyFest. We also have \$495.43 remaining in this year's budget. There was discussion of donating \$500.00 towards the purchase of Otter Falls. The \$500.00 donation would be matched dollar for dollar translating into \$1,000.00. Kay Lambert recommended that the Recreation Commission make a \$500.00 donation to the purchase of Otter Falls. Anne Fontaine seconded the motion, and it passed.

Someone in town brought up the idea of the possibility of converting one of our tennis courts to a Pickle Ball court. One option would be to convert one of the tennis courts, the other option would be to make a Pickle Ball court on left hand side of tennis courts between existing fence and the private road. We will check into these options over the winter and revisit in the spring.

Membership Recommendation – Leigh Sasse made a motion to recommend Anne Fontaine for another term on the Recreation Commission. Kay Lambert seconded the motion, and it passed.

**Old Business**

Playground Shade Structure Update - We have the Shade Structure but it has not been erected yet. We may wait until the spring to erect the structure.

Walking Challenge Wrap Up – We have 49 participants. The challenge officially ends on Monday, September 30<sup>th</sup>. There will be a final group walk. We will walk from Town Hall up Alpine and back to Town Hall. This is a total of 1.5 miles. The walk will start at 4:30 and our party will follow immediately at Town Hall. Anne Fontaine brought ribbons and labels to the meeting. The labels were filled out with each participant's name. The total miles will be filled out once the challenge ends. We will also have another label on each ribbon for each person that completes the Alpine walk. Kay Lambert will bring water, energy bars, plates, napkins, cups and forks. Leigh Sasse will order a cake from Lowes and make trail mix and bring another beverage. Anne Fontaine will check with Mike Potter about the prizes. We will meet at Town Hall at 4:00 on September 30, 2013 to set up for party.

Leigh Sasse made a motion to adjourn. Kay Lambert seconded the motion, and it passed.
