**Call to Order**

Continuation Meeting

May 3, 2011

The Seven Devils Planning Board met for a continuation meeting on Tuesday, May 3, 2011, at Town Hall. Members present were Chairman Bob Haugh, Vice-Chair Butch McLean, Members George Ehlinger, Barry Isquith and Mike Tarlton. Member Barbara Williams was absent and excused. Member Larry Fontaine arrived after the meeting was underway. Also present was the Town Manager and Zoning Administrator, Ed Evans. The minutes were recorded by Beth Taylor, Town Clerk.

Chairman Haugh brought the meeting out of recess at 4:35 pm.

The meeting continued as in previous meetings. The Members read over the proposed changes and discussed at length possible corrections. Once the entire proposed Unified Ordinance was discussed, Zoning Administer Evans reminded the Members that the next step is to approve the document and send it to the Town Council for their review. Once the Council has reviewed it they will schedule a Public Hearing before finally adopting the new Unified Ordinance. Evans stated that he will try to get the corrected Ordinance to all Planning Board Members in time for them to review it before the next regularly scheduled meeting on May 16.

Before closing the meeting, Chairman Haugh asked if there were any citizen comments. Carroll Berkley, of Hawkspeak West Unit 112, asked the Members to define a manufactured home. Zoning Administrator Evans replied there are modular manufactured homes and mobile manufactured homes. The easiest way to distinguish them is that a mobile manufactured home has a HUD sticker and a number on it. A modular manufactured home does not.

As there was nothing further to discuss at this time, Member Fontaine made a motion to adjourn. Member Isquith seconded the motion. The Members agreed unanimously. The meeting adjourned at 5:35 pm.
